#### **CALENDAR DESCRIPTION:**

This is an advanced and specialized course in individual studio work, which affords students opportunities for interdisciplinary and collaborative approaches and oversees the development of independent study strategies. Students will research and complete a major self-directed project. This course is not intended for all Honours students. This course is intended to assist in the preparation for graduate school and professional activities in the Arts.

**Prerequisite(s):** A minimum of 0.50 credits at the 4000-level in Studio Arts, a minimum cumulative average of at least 80% in SART courses and ARTH courses., 6.50 credits in SART and ARTH

**Restriction(s)**: Instructor consent required. Selection is by a process of portfolio submission and interview.

# **COURSE DESCRIPTION AND EXPECTATIONS:**

Specialized Studio affords students the opportunity to develop independent studio work, and assists students in preparation for graduate school, and for life as a professional artist.

The course is scheduled twice a week, three hours per class. Typically, one of these classes will be a seminar/lecture and the other a supervised work period. Attendance at Studio Program Visiting Artist lectures is a required part of the course. Students are also strongly encouraged to attend exhibitions and events in Toronto, Guelph, and other centers in Southwestern Ontario. While the focus of this course is on individual production, each student is expected to contribute to a supportive, dynamic and critical community. Participation in scheduled activities and critiques is therefore essential.

Students are required to complete a substantial body of work each semester. It is expected that student work will incorporate significant research and be ambitious both in scope and in realization. Feedback on work in progress will be available from the instructor, classmates, and the GTA. Students are strongly encouraged to invite other faculty members and graduate students for studio visits during the semester. Studio work will be formally reviewed at a midterm critique, and at a final critique, which will be attended by a guest examiner.

NOTE: This is a 1.0 credit course. Each week, students are expected to spend approximately 10-12 hours outside of class time on related course work.

## **LEARNING OUTCOMES:**

- Ability to conduct research and create work independently
- Ability to introduce issues from the discourse of contemporary art in critical discussions and in writing
- Increased comfort in critiquing a variety of aesthetic positions in a public forum
- Develop more advanced skills at analyzing and discussing art works in a critical context
- Develop their capacity to apply for graduate study in studio art, and increase their familiarity and participation in a wider professional field

## **LAB FEES:**

A compulsory materials fee of \$65.00 will be charged for materials and services provided in support of required course projects. The amount will be invoiced by the Office of the Bursar and paid directly with your tuition payment. THE LAB FEE WILL NOT BE REFUNDED AFTER THE THIRD WEEK OF CLASSES. (Refer to Classification Changes, Undergraduate Calendar, 2016-2017). An additional Materials Fee will be assessed based on the area students will be working in. Payment is due directly to the Instructor at the beginning of each semester (cash or cheque payable to School of Fine Art and Music).

## **COURSE REQUIREMENTS:**

- **1. Artist Statement (10%).** Students must write an artist statement about a classmate's work.
- 2. Research presentation. (15%) This includes a bibliography of relevant readings, a list of artists, a vocabulary list pertinent to each student's art practice, and key phrases culled from readings. This exercise will assist students with basic research that will form the critical underpinning of their work.
- 3. Studio visits and mid-term critiques (20%)

Students should have new work-in-progress to discuss at studio visits at least every second week. Participation in mid-term critique sessions is an important course requirement.

- 4. A significant body of work at end of semester critiques (40%). This is a 1.0 credit course, so students are required to invest a significant amount of work both in class and outside of class on art production. Visual work must be based on visual, textual, and material research, and be well defended at critiques. Final work must be presented and mounted or displayed to professional standards. Critiques should be treated like an exam.
- 5. Participation: Critiques, visiting speakers, and discussions. (15%).

  Participation/attendance at critiques, visiting speaker presentations, class discussions, field trips, and scheduled studio visits is mandatory.

## **SAFETY/STUDIO MAINTENANCE:**

Safety in the studio is a priority at all times. It is imperative that students follow all health and safety procedures and always use the appropriate safety equipment. It is also imperative that the studios and the building remain clean. Students are responsible for the repair of any damage caused to the facility. Grades will be withheld until individual studio spaces pass inspection.
