CALENDAR DESCRIPTION:

This course is a study of music theory and analysis. It builds on rudiments and musicianship skills developed in MUSC*1180 and introduces students to materials of music including melodic construction, phrase structure, linear counterpoint, rhythmic organization, and diatonic harmony. Students will work on both applied and analytical assignments.

Prerequisite(s): MUSC*1180

Restriction(s): MUSC*1250, MUSC*2360

COURSE DESCRIPTION:

The student will study of the materials of music, focusing mainly on common-practice tonal music but also including pre-tonal music. The aim is to develop an understanding of both the linear (melodic, polyphonic) and the vertical (harmonic) elements underpinning musical organization. Students will learn about music through study of score excerpts and through exercises that entail application of principles from historical repertoire. Analytical tools will be studied that will aid in understanding phrase structure, rhythmic organization, harmonic progression, and larger-scale form.

LEARNING OUTCOMES:

- Mastery of music rudiments
- Comfort reading music from scores
- Understand principles of counterpoint, voice-leading and harmony
- Ability to analyze tonal music for harmonic organization, phrase structure and form
- Ability to use music notation software
