CALENDAR DESCRIPTION

Contemporary issues in interdisciplinary art production will be addressed through at least two thematic projects and one self-directed work based on the students' own research in close consultation with the instructor. Students may choose to pursue and perfect one medium, or take a more interdisciplinary approach to art production.

Prerequisite(s): 1 of SART*3770, SART*4660, SART*4670

Restriction(s): Registration is limited to students registered in the Art History or Studio Art specializations of the Bachelor of Arts program with an average of 70% in all ARTH and SART course attempts.

COURSE DESCRIPTION:

This course is designed to establish a focused and individual approach to art production in preparation for independent research and production. The semester will include introductory exercises, readings, a class field trip, two thematic assignments, and a major final project. Works produced in class will be documented and archived by students on the course blog throughout the term with images and textual descriptions.

Our class dynamic is of primary importance, and participation in the studio community is essential to develop a critical and supportive atmosphere. This practice should extend to the larger art community, as students begin to participate within a broader context.

NOTE: this is a 0.5 credit course. Each week, students are expected to spend approximately 4 –6 hours outside of class on related course work.

LEARNING OUTCOMES

Students will develop a greater familiarity with multi-disciplinary contemporary art practices.

Students will develop more refined strategies for using the tools and materials of multidisciplinary art production.

Students will develop skills at researching and creating projects independently.

Students will develop more advanced skills at analyzing and discussing art works in a critical context.

Students will develop their familiarity and participation in the wider professional field.

LAB FEE:

A compulsory materials fee of \$55.00 will be charged for materials and services provided in support of required course projects. The amount will be invoiced by the Office of the Bursar and paid directly with your tuition payment – no additional payment is necessary. **THE LAB FEE WILL NOT BE REFUNDED AFTER THE THIRD WEEK OF CLASSES.**

Late work will not be accepted. Students are expected to hand in all assignments and have all work ready for critique by the deadline. Late works will receive zero unless exceptional circumstances arise.

Attendance at studio classes is mandatory. Students who miss three or more classes will receive 0 in participation unless exceptional circumstances arise.
