## 1 Course Details

## 1.1 Calendar Description

In art, the 20th century has been referred to as "The American Century." Artists in the USA have a tradition of creating new visual languages, of using new ideas and technologies, and of representing the vanguard. Where did these ideas originate, and how has the USA determined our notions of what art is? This survey course focuses on modern American artists, on the evolution and growth of modern visual culture, and on how technologies and societies impact on artistic taste.

# 1.2 Course Description

This course considers American art, and its specific formulations of modernism, postmodernism, contemporary art and visual culture from the late 19<sup>th</sup>century to the present. It will address the ways that artists imagine both the particularities of region and the presence of the U.S. in the context of globalization. Of specific interest will be the questions of identity, place, economies of the image and techniques of vision.

## 7.5 Accessibility
