## **1 Course Details**

### **1.1 Calendar Description**

This course will provide an in-depth examination of the critical issues driving contemporary art. Though the specific topic will vary, the goal of this course is to establish a facility with the fundamental terms by which to analyze the cultural, economic, technological and visual conditions that shape the artworks of our time.

**Pre-Requisites:** 

7.50 credits or 1.50 credits in Art History, including ARTH\*2480.

### **1.2 Course Description**

This course focuses on socially engaged and activist art practices. We will consider the strategies and uses of artistic aesthetics taken up by individuals and collectives for the purpose of social interaction, intervention, or political change. We will explore the materials, methods, and theoretical approaches taken by artist activists through readings, case studies, and student projects. We will consider existing scholarship on socially engaged art, as well as closely analyze specific practices on a local, national, and global scale. Together we will investigate and assess the value of these hybrid practices as aesthetic and political activities.
