## 1 Course Details

### 1.1 Calendar Description

This course examines how the theory and practice of art history has often been informed by biography and other constructions of stereotypes and social practices concerning the 'Artist', the artist's audiences, and the various contexts that inform artists' lives, real and imagined.

**Pre-Requisites:** 7.50 credits or 1.50 credits in Art History.

### 1.2 Course Description

This course focuses on how biographical narratives can inform, and misinform, our understanding of art. In our effort to comprehend the value and limitations of biographical approaches, we will consider a range of historical and contemporary art practices and writing. Together we will think critically about how art scholarship and exhibition practices have foregrounded biography as a tool in the reception, promotion, and sometimes, the marginalization of artwork.

## 7.5 Accessibility
