1 Course Details

1.1 Calendar Description

This seminar explores theories and methodologies in art history and visual culture in relation to a specific theme depending on the expertise of the instructor.

1.2 Course Description

This seminar examines the presence of raw materials and more broadly natural materialities in the arts, as an essential yet undertheorized field that provides critical insights into the current ecological crisis. The recent price inflation following the COVID crisis and the invasion of Ukraine by the Russian army have brought our attention back to raw materials, reminding us of their importance for the economy and for our daily lives. But their centrality to any given human society extends way beyond these recent episodes. Studies in art history showcase different types of raw materials, such as sugar, spices, silver, rubber, coffee, cotton, etc. that are often intertwined with colonial and imperial domination. However, they are rarely considered comprehensively and in continuity with today's patterns of extraction.

Whether they appear as representations, evocations, traces, or whether they are physically staged in the artwork, natural materialities displayed in art offer a crucial perspective on the economic domination of nature. This seminar aims to explore through art how the crises we face today, especially at an ecological level, are connected to this economic imperative of consuming and exploiting nature. Artworks showcasing natural materialities become a unique means to unearth histories of exploitation and forge decolonial alternatives.

7.4 Copies of Out-of-class Assignments

7.5 Accessibility
