**COURSE OUTLINE**

**Calendar Description:** “This course augments CLAS\*2350 for students of Latin through the reading and study in Latin of certain primary sources.”

**Course Description:** Advanced study of Latin language and literature through the reading of selections from the Augustan poet Ovid’s *Metamorphoses* in the original.

**Prerequisite(s):** LAT\*2000.

**Required Text:** *The Student’s Ovid: Selections from the Metamorphoses*, ed. Margaret Worsham Musgrove (University of Oklahoma Press, 2000) ISBN 978-0-8061-3220-4

**Presentation:** The course will be offered synchronously through Teams. In-class translation.

**Participation:** As with any language, the learning of Latin requires the investment of time and effort on a consistent basis. **Regular class attendance and participation, together with prior preparation and subsequent review are necessary to ensure success.** All students are expected to come to each class having prepared a written translation of the assigned Latin readings, and to be willing to offer their English rendition when called upon to translate in class.

The tests and final examination will be written synchronously. The dates of the two tests will be announced in advance in class and via CourseLink.

**Learning Outcomes:** The student, upon the successful completion of this course, will:

- possess the ability to read the texts of Latin authors in the original language;
- gain knowledge of Latin scansion, in particular dactylic hexameter.
