**COURSE OUTLINE**

**Calendar Description:** “This course augments CLAS\*3030 for students of Greek.”

**Course Description:** Advanced study of the vocabulary, grammar and syntax of ancient Greek through readings in the original.

**Prerequisite(s):** GREK\*2020.

**Required Text:** *Athenaze: An Introduction to Ancient Greek*, Book II, 3<sup>rd</sup> ed., ed. Maurice Balme and Gilbert Lawall (Oxford University Press, 2016) ISBN 978-0-19-060767-8

**Presentation:** The course will be offered synchronously through Teams. In-class translation; exercises on grammar and syntax.

**Participation:** As with any language, the learning of ancient Greek requires the investment of time and effort on a consistent basis. **Regular class attendance and participation, together with prior preparation and subsequent review are necessary to ensure success.** All students are expected to come to each class having prepared a written translation of the assigned Greek readings and exercises, and to be willing to offer their English rendition when called upon to translate in class.
