## 7 Course Statements

### 7.1 Comment réussir dans ce cours?

Lisez les chapitres à l'avance pour mieux vous préparer à la pratique en classe (voir échéancier).

Travaillez le plus possible le français oral, non seulement en participant au cours, mais aussi en regardant la télévision ou en écoutant la radio française et francophone, en regardant des séries ou des films français en VOST (=Version Originale Sous-Titrée) et en parlant autant que possible aux francophones de votre entourage si vous en connaissez.

Pendant les cours, prenez des notes, notamment sur le vocabulaire et les apports théoriques!

### 7.2 Transcriptions et chansons

*Chaque semaine*, afin de travailler votre oreille, vous aurez **une vidéo** (3m max.) à transcrire. Je vous donnerai le lien en classe et sur CourseLink chaque mercredi pour que vous puissiez travailler sur le contenu le vendredi. Le lundi suivant, nous prendrons quelques minutes en classe pour discuter du contenu, de vos remarques et des difficultés que vous avez éventuellement rencontrées.

De la même manière, je vous donnerai chaque mercredi une chanson française ou francophone à écouter afin de travailler votre oreille et vous faire connaître quelques incontournables du répertoire musical français par la même occasion.

### 7.3 Quiz

*En semaines 3 et 7*, vous aurez à faire deux quiz asynchrones. Dans le premier quiz vous répondrez à des questions (Vrai ou Faux) portant sur le chapitre 1. Lors du deuxième quiz, vous visionnerez trois vidéos et répondrez à des questions liées aux thématiques exploitées et/ou sur le contenu.

### 7.4 Enregistrement

*En semaine 5*, vous aurez à me remettre un **enregistrement audio de 3m** maximum en format MP3 sur la Dropbox. Il s'agira d'un compte-rendu oral (résumé + critique/réactions) qui portera sur une vidéo de plus ou moins de 30 minutes. Vous aurez le choix entre plusieurs vidéos qui traiteront de sujets différents. A vous de choisir celui que vous préférez pour ce travail individuel.

Vous serez noté.e sur la qualité du français et la pertinence des remarques.

## 7.5 Exposé-débat

À partir de la semaine 10, nous allons commencer les **exposés**. **Cet exercice est un travail de groupe. Chaque exposé dure 10 minutes** et traite un sujet de société choisi dans une liste que je vous fournirai.

Lors de cet exercice, chaque groupe développera les différents aspects de la question : pour ou contre.

Attention à parler à partir de notes et non de lire un texte rédigé à l'avance (au risque de perdre des points).

L'évaluation sera basée sur la qualité du français, la clarté de l'exposé, l'étendue des connaissances et les réponses données aux questions posées par la classe.

## 7.6 Entretien oral

En semaine 13, je vous retrouverai pour un **entretien individuel de 10m maximum** qui portera sur un sujet étudié en cours pendant le semestre. Je vous communiquerai sur CourseLink une liste des sujets potentiels. Vous aurez un sujet au hasard le jour de l'entretien.

Votre note dépendra de la qualité et de la richesse du français. Ce sera l'occasion d'utiliser le vocabulaire étudié pendant le cours.

## 7.7 Politique en matière de pénalité de retard à la remise des travaux

Tout travail soumis en retard sera sujet à une pénalité de 2% par jour, y compris les fins de semaine, à moins de présenter une pièce justificative et/ou d'envoyer un message à la professeure. Aucun travail ne sera accepté après le dernier cours. En cas de force majeure (maladie, décès, hospitalisation), les étudiants auront le droit de rattraper une évaluation manquée.

### **3. Drop Date**

### **4. Copies of Out-of-class Assignments**

### **5. Accessibility**
