COURSE OUTLINE

Prerequisite: none

Course objectives:

1. to introduce students (without prior knowledge) to the CLASSICAL Greek language to enable them to read with fluency Greek texts written over more than two millennia once the upper Greek courses are completed.
2. to identify and analyze the essential forms, grammar, and syntax of the Greek language including:
 - the use of cases and parts of speech
 - declension of nouns and adjectives
 - conjugation of verbs in the present, future, and aorist tenses
3. to construct an introductory Greek vocabulary (approx. 1000 words)
4. to translate passages of Greek prose and some verse into idiomatic English with some vocabulary aid
5. to infer the meaning of English words using his/her knowledge of Greek vocabulary
6. to demonstrate knowledge of some aspects of Greek civilisation, using adapted written texts
7. for many, to gain a better understanding of their native language

Accessibility
