### COURSE OUTLINE

**Prerequisite:** LAT\*1100

#### **Course objectives:**

1. to further students' knowledge of the Latin language, building upon what was learned in LAT\*1100 to enable them to read with fluency Latin texts written over more than two millennia once the upper Latin courses are completed.
2. to continue to identify and analyze the essential forms, grammar, and syntax of the Latin language including:
  - the use of cases and parts of speech
  - declension of nouns and adjectives
  - conjugation of verbs in the present, imperfect, perfect, pluperfect, future perfect and future tenses in both active and passive voices.
3. to continue to construct an introductory Latin vocabulary
4. to translate passages of Latin prose into idiomatic English with some vocabulary aid
5. to infer the meaning of English words using his/her knowledge of Latin vocabulary
6. to demonstrate knowledge of some aspects of Roman civilisation, using adapted written texts
7. for many, to gain a better understanding of their native language

#### **Required Text (already acquired by most students for LAT 1100):**

*Wheelock's Latin*, F.M. Wheelock and R. Lafleur (Harper Collins, 2011) 7th Edition.
