Restriction(s): Registration in a Music Program (Honours Major or Minor, General).

COURSE DESCRIPTION:

Students will have the opportunity to continue to apply skills learned in the core of the music program to creative musical activity, focused on improvising on their own instrument(s) with others, and the writing of scores and/or the production of electroacoustic studio works. Students will work on improvisational and compositional activities appropriate to their level of experience and creative goals. There will be more of a focus on individual work. Students will explore a variety of styles within the broad topics being introduced. Listening and research (e.g., techniques, score study, notation, instrumentation) are core elements of the course, and students will need to devote substantial time to these. Students will be expected to develop more ability to articulate formal design and musical/cultural contexts as these apply to their creative work. Group performance, both improvisational and score-based, is critical to the goals of the course, so regular attendance is essential.

Students may continue on to MUSC*3420 in Winter. It is also possible to go on to present a composition/improvisation recital in MUSC*4460 and MUSC*4470.
