1.1 Calendar Description

This course introduces students to music research at the postsecondary level, exploring aural phenomena within the subdisciplines of popular music studies, ethnomusicology, musicology, ecomusicology, and sound studies. Emphasising interdisciplinary, multicultural approaches to analysing sound, this course explores such topics as music and power, music and identity, music and the environment, music and appropriation vs. appreciation, and music and psychology.

6 Assessments

6.1 Assessment Details

Classroom Participation (20%)

Date: Mon, Sep 12 - Fri, Dec 2, In-class

Music Research Toolbox Notebook (20%)

Date: Mon, Sep 12 - Fri, Dec 2, In-class

Students will complete a toolbox notebook throughout the course. This notebook is designed to be carried throughout the student's music studies at Guelph and will provide a summary of all the tools and techniques involved in conducting music research.

Listening Tests (20%)

Date: October 5 and November 16, In-class

Two listening tests will be conducted over the course of the semester. All excerpts will be pieces discussed in class. Students will be expected to identify the name of the work, its composer, its performer (if applicable), and the defining aural features of the piece.

Midterm Exam (15%)

Date: Wed, Oct 19, In-class

Midterm will be held in-class, and will be the full class period (90 minutes). Students may use any and all notes contained within their Toolbox notebook to assist with writing the exam.

Exam (25%)

Date: Fri, Nov 25 - Fri, Dec 9, Take-Home Final Exam

Students will be assigned a musical example to research and then discuss in their own words. The professor will meet with each student at the one-week mark to discuss their findings and provide feedback. Students may either submit their final analysis as a written summary or a recorded video. Students may use their Toolbox Notebook as a resource. Everyone will have two weeks to complete their assignment.

7.4 Copies of Out-of-class Assignments

7.5 Accessibility
