1 Course Details

1.1 Calendar Description

This course provides a foundation in the technical and theoretical aspects of contemporary three-dimensional and time-based media. Through a combination of lectures, studio projects and guest speakers, students will explore perceptual, conceptual and topical dimensions of contemporary art making practices.

Restrictions:

Registration in semesters one, two, three or four. May not register in SART*1050 in the same term. This is a Priority Access Course. Enrolment may be restricted to particular programs or specializations during certain periods. Please see the departmental website for more information.

1.2 Course Description

This course consists of a two-hour lecture and a four-hour studio each week. Presentations in the lecture part of the course provide an overview of the theoretical and historical foundations of contemporary art, with a focus on 3-dimensional and time-based media. Students will complete three project units, which cover a range of technical skills and creative approaches. Each unit will take a general topic as a starting point for studio explorations and skills development. Group and individual critiques and discussions with the instructor will form a part of the studio time.

NOTE: This is a 0.5 credit course. Each week, students are expected to spend 4–6 hours outside of class on related course work.

COURSE OBJECTIVES:

The aim of this course is to develop foundational knowledge of contemporary art making. By experimenting with a variety of production techniques, the student will gain first hand experience with the pleasures and challenges that an artist experiences in the exploration of different materials, methods and concepts. Lectures will provide the students with a historical understanding of the field.

The objectives of this course are to:

1. Introduce basic concepts and techniques of sculpture and time-based media.
2. Establish an historical context for contemporary art.
3. Provide a foundation for critically analyzing art work.

7.1 Lab Fee

A compulsory materials fee of \$30.00 will be charged for materials provided in support of required course projects.

The amount will be invoiced by the Office of the Bursar and paid directly with your tuition payment – no additional payment is necessary. **THE LAB FEE WILL NOT BE REFUNDED AFTER THE THIRD WEEK OF CLASSES.**

Students will also be required to purchase a sketchbook.

PLEASE NOTE: Under no circumstances should a student be required to pay any additional monies for supplies needed to complete course assignments – excluding items listed under “Items Provided by the Student”. 8.4 Copies of Out-of-class Assignments
