1 Course Details

1.1 Calendar Description

This course will study the technical development of observational drawing as well as the experimental and intentional development of drawing as a contemporary art form. Drawings will be made and discussed with attention to semiotic theory in order to examine the production and interpretation of meaning.

Pre-Requisites: SART*3090

Restrictions: Registration is limited to students registered in the Studio Art

Major with an average of 70% in all ARTH and SART course attempts. This is a Priority Access Course. Some restrictions

may apply during some time periods.

1.2 Course Description

In the Fall 2020 iteration of Drawing III, we will explore post-studio approaches to drawing, in part in response to the current historical moment but also as a means of preparing each participant to continue to practice art once they leave the institution. We will consider how and where to work and expand the range of tools, technology and conceptual approaches available to each participant. The materials we use will be wide-ranging and, for the most part, up to each individual.

We will meet together online to discuss images and texts that support the projects, and to discuss and provide feedback upon your work. The projects will initially build upon skills in observational drawing, related specifically to questions of technology - digital, photographic or otherwise. In subsequent projects we will explore site-specificity and performative or procedural drawing, as well as other contemporary approaches to drawing. The aim of the course is to support each of you in the development of your own voice, research interests and expression.
