# **1 Course Details**

## **1.1 Calendar Description**

This course will study the technical development of observational drawing as well as the experimental and intentional development of drawing as a contemporary art form. Drawings will be made and discussed with attention to semiotic theory in order to examine the production and interpretation of meaning.

Pre-Requisites:SART\*3090Restrictions:Registration is limited to students registered in the Studio Art<br/>Major with an average of 70% in all ARTH and SART course<br/>attempts. This is a Priority Access Course. Some restrictions<br/>may apply during some time periods.

## **1.2 Course Description**

This course will advance contemporary approaches to drawing and continue with the development of the students' representational/observational, material/process-based explorations and technical drawing skills. Class readings, discussions and assignments will explore experimental forms of contemporary drawing as students move toward developing an independent drawing project in the last half of the course.

Drawing III will combine both in-person and remote instruction. The majority of classes will be conducted in-person, including critiques, lectures, tutorials, reading discussions and work periods. A Microsoft Teams for Drawing III will serve as a collaborative platform for asynchronous class discussions, the sharing of news and references and for student presentations and lectures. Students are encouraged to work from home during scheduled work periods.

## 6.1 Assessment Details

Reading Responses (20%) Date: Ongoing Learning Outcome: 1, 3, 4 4 total (5% each)

A selection of critical texts will be the basis of our class discussions. Students are expected to engage through written responses and class participation. A more detailed description of the reading assignments will be distributed in class.

#### **Project 1: Photographic Source (10%)**

Due: Week 3

#### Learning Outcome: 1, 2, 3, 4

Two or more drawings, made in and out of class. Students will explore a variety of markmaking using one photographic source. A more detailed description of the requirements will be discussed in class.

Due for review Sept 26 Final due Sept 28

### Project 2: Using collage OR cutting out (10%)

Date: Week 4

#### Learning Outcome: 1, 2, 3, 4

Two works made with some form of collage or cutting out. A more detailed description of the requirements will be discussed in class.

Due for review on October 3 Final due October 5

#### Project 3: Site-specific drawings (from observation) (10%)

**Date:** Week 7 **Learning Outcome:** 1, 2, 3, 4, 5

Students will draw two works <u>from observation</u> using different approaches from the same location. A more detailed description of the requirements will be discussed in class.

Due for review on October 24 Final due October 26

#### Project 4: Expanded drawing through performance OR video (10%) Date: Week 9

One drawing using performance, objects or video. A more detailed description of the requirements will be discussed in class.

Due for review on Nov. 7 Final due Nov. 9

### **Project 5: Independent Project (30%)**

Date: Week 12

Students will undergo an ambitious independent project of their choice. A more detailed description of the requirements will be discussed in class.

Due Interim critique (review) on November 14/16 (%10) Final critique November 28/30 (20%)

#### Participation (10%)

Date: Ongoing

Learning Outcome: 1, 3, 4

The full participation of each student in this course is integral to its success. Active participation allows for the voicing of diverse ideas and perspectives, the reflective interpretation of works and the effective communication of intentions. Communication is central to creating connections to shared ideas and for re-evaluating entrenched biases and habits, which can help in creating a productive working foundation to help move the work forward.

Student participation is a critical aspect of critiques. Critiques are an essential part of the creative process that divides time in the studio between creation and judgment. They foster the necessary skills required to effectively communicate discoveries and evaluations to ones peers and to the larger community.

Each critique functions as an exam.

Projects must be complete and presented in a professional manner before the critique due dates.

Attendance is Mandatory.

## 6.2 Grading Criteria

Grades are assigned using the following criteria:

- The artwork and preparatory work demonstrate experimentation with materials and processes and meets professional standards.
- The artwork meets or exceeds the challenges posed by the assignment criteria and student objectives of the project.

- The artwork demonstrates relevant links between the aesthetic and the conceptual objectives of the project.
- The student presents evidence of research and preparatory work.
- The artwork demonstrates an innovative use of materials and processes and a novel interpretation of the assignment criteria.
- The artwork and preparatory work demonstrate the development of technical skills.

### Participation will be based on the following criteria:

- The student regularly attends and participates in formal and informal critiques and discussions.
- The student shows active participation in class by arriving on time, arriving prepared and ready to work during class time, and fostering a community that is respectful of different opinions and values
- The student participates or conducts a discussion in a fair and considerate manner.
- The student participates in fostering a creative and dynamic class environment.

# 7 Course Statements

## 7.1 Course Requirements

Student projects will be supported by a regular ongoing review of the student's progress either in one-on-one or group discussions to encourage both exploration and to strengthen the effectiveness of the project. It is recommended that students develop their projects within the dedicated space of the classroom.

For site-specific drawings or if working outside the classroom the student must have regular access to the work to track progress.

Students are expected to help maintain the drawing facilities so they remain in suitable working conditions for all class members. \*Spray fixative should only be applied to drawings in the ventilated spray room (Alexander Hall Rm. 373). The use of natural and non-toxic casein fixatives is recommended.

Drawings should be protected temporarily with a covering sheet of clean newsprint until an appropriate opportunity arises for applying fixative. The critique wall in the classroom must be kept clean and unobstructed for critiques. A roll of paper is provided in the drawing room to cover and protect the wall surface if working directly on the classroom wall as a support

surface.

- Each student will complete 4 drawing assignments, a major project and submit reading responses for required readings.
- Each project must be thoroughly researched.
- Drawing III is a studio course scheduled twice a week, three hours each class. A range of information from image presentations, discussions (both formal and informal) will take place during the semester making regular attendance necessary. In addition to in-class time, students are expected to devote 4 6 hours outside of class in order to adequately realize projects.
- Contributing to a supportive, dynamic studio is essential. This includes active participation in class discussions and critiques, arriving on time and remaining productively involved in each studio class. Participation and practice are essential for the effective acquisition of technical skills.
- Students will participate in group critiques and discussions with a thoughtful, supportive and critical mind.
- Projects must be completed before the final critique due dates.

## 7.2 Lab Fee

A compulsory lab fee of **\$25** will be used for the purchase of some drawing supplies. This amount will be invoiced directly by the Office of the Bursar. **THE LAB FEE WILL NOT BE REFUNDED AFTER THE THIRD WEEK OF CLASSES.**

PLEASE NOTE: Under no circumstances should a student be required to pay any additional monies for supplies needed to complete course assignments – excluding items listed under "Items Provided by the Student". ## 7.3 Special Statement on Course delivery for Fall 2022

SART\*4090 is an "in-person" course and the drawing studio is the primary site for class discussions and working on assignments. PPE requirements for occupation of the studio must be observed at all times by all students.
