### 1 Course Details

### 1.1 Calendar Description

This is an advanced course which explores drawing through individually oriented production supported by critical study of diverse contemporary approaches to the medium. In this course drawings will continue to be considered in the light of semiotic theory in order to examine the production and interpretation of meaning.

**Pre-Requisites:** SART\*4090

**Restrictions:** Registration is limited to students registered in the Studio Art

Major with an average of 70% in all ARTH and SART course attempts. This is a Priority Access Course. Some restrictions

may apply during some time periods.

# 1.2 Course Description

SART\*4130 Drawing IV follows directly from SART\*4090 Drawing III. In that class students will have begun to identify areas within the breadth of drawing practices that of interest to them as creative practitioners.

This is a 1.0 credit course where students will produce a body of self-directed works. That work will be conceptually cohesive and display critical thinking with regard to issues in contemporary art. Their work will show an understanding of the potential for drawing as an activity in itself and a related understanding of the potential of the viability of drawing as a "self-contained" activity, distinct from other disciplines and media. Students will be able to discuss their work, and the work of others, while addressing issues arising from contemporary drawing practices.

The self-generated student drawing projects will be supported by a series of seminars examining ideas in contemporary and modern drawing and looking at the work of makers. Performance in seminars will be evalated, as will student work in midterm and final critiques.

As a result of COVID-19, this class will be remotely delivered. The class will meet once each week for seminars, group discussion of student projects and online drawing workshop activities. The instructor will meet with students in the class individually by appointment to discuss the progress of their work. All students can study in this class entirely online. However, if Public Health and university guidelines allow, there will be limited access to the Alexander Hall Drawing Studio
