ESQUEMA DEL CURSO (COURSE OUTLINE)

Descripción del curso (Course Description):

Este curso analiza la evolución del español moderno desde el latín vulgar. Algunos temas que se tratarán incluyen el cambio de las lenguas; la genealogía del español; la historia externa de la Península Ibérica; los rasgos del latín; cambios en la fonética, la morfología y la sintaxis del latín y del español medieval y del español medieval al español moderno; el léxico del español y las variedades dialectales del español. El curso ofrece un complemento al conocimiento del español adquirido en cursos anteriores situándolo en un contexto sociocultural, y contribuirá a la adquisición de la lengua mediante el estudio del trasfondo que forjó el español moderno.

Libro de texto (Required Text)

- Pharies, David A. 2015. "Una breve historia de la lengua española."
- Textos para análisis y otros materiales se presentarán en la clase.

Resultados cognitivos (Learning Outcomes):

Habiendo terminado con éxito el curso, los estudiantes podrán:

- Describir los procesos de cambios en la lengua más importantes en relación a la evolución del español desde sus principios en el latín vulgar.
- Describir algunos eventos históricos claves que han impactado el desarrollo de la lengua en la Península Ibérica.
- Explicar, usando terminología de la lingüística los cambios fonológicos y morfosintácticas en el desarrollo del español moderno.

- Explicar el papel del contacto entre las lenguas en el desarrollo del español estándar y las variedades regionales habladas.
- Analizar textos escritos en español medieval para identificar algunos cambios lingüísticos.

Métodos de presentación (Methods of Presentation):

Los alumnos podrán profundizar su conocimiento sobre la historia de la lengua participando en discusiones en clase, o trabajando en grupos sobre algunos elementos claves de la evolución del español desde el latín hasta los tiempos modernos.
