COURSES TAUGHT RECENTLY

Canadian Economic History (ECON*2420) surveys economic development in Canada Advanced Topics in Economic History (ECON*4720)

Economic Development in Historical Perspective (ECON*6370) is designed for social science MA students. It surveys the influences and events that have contributed significantly to the patterns of global inequality in income and in health.

The World Economy since 1850 (ECON*3720) is taken by senior BA and BComm students. It surveys the evolution and sources of growth in the international economy during the 19th and 20th centuries with particular interest in the interplay beween global and local.

Europe and the World Economy to 1914 (ECON*3730) examines the contrast between pre-modern and modern patterns of economic development and the origins and impact of the 'industrial revolution' on health and well-being for senior BA and BComm students.

Life, Death and Migrations (HIST*4450) introduces History students to the use of quantitative sources and techniques in historical research.
