Evaluation of this course will take place at some point during the last two weeks of the semester.

Seminars : Presentations are restricted to a maximum 20 minutes. Everyone in the class is expected to have completed the readings and to have thought about them sufficiently to participate in the group discussion. Therefore no more than a very brief summary is needed. The presenter(s) should aim to illustrate the importance and relevance of the topic in the light of contemporary issues. In some cases, the presenter(s) will want to report upon additional literature in order to situate and motivate the particular readings that have been assigned. Students are encouraged to consult the instructor regarding their plan for the seminar.

Research Essay : Preparation of an essay provides the opportunity to examine in a more detailed way a particular region, activity, process or current issues. Students may select a topic related to one of the seminar discussions but that is not required. Students may consult the instructor regarding preparation of research essay.

Grading Standards for Essay

"A" work (1) Has a thesis that falls within the framework of the course

- (2) Expresses its purpose clearly and persuasively
- (3) Begins and ends effectively
- (4) Provides adequate supporting arguments, evidence, examples, and details
- (5) Is well-organized and unified
- (6) Uses appropriate, direct language
- (7) Correctly acknowledges and documents sources
- (8) Is free of errors in grammar, punctuation, word choice, spelling, and format

(9) Maintains a level of excellence throughout, and shows originality and creativity in realizing

(1) through (6)

"**B**" work Realizes (1) through (8) fully and completely -- and demonstrates overall excellence - but shows little or no originality, creativity or analytical sophistication.

"C" work Realizes (1) through (8) adequately -- and demonstrates overall competence -- but contains a few, relatively minor errors or flaws. A "C" paper may show great creativity and originality, but those qualities don't make up for poor or careless writing. A "C" paper often looks and reads like a next-to-final draft.

"**D**" work Fails to realize some elements of (1) through (8) adequately -- and contains several, relatively serious errors or flaws, or many minor ones. A "D" paper often looks and reads like a first or second draft.

"F" work Fails to realize several elements of (1) through (8) adequately -- and contains many serious errors or flaws, and usually many minor ones, as well. An "F" paper often looks and reads like a very preliminary draft.

Book Review

The book review will examine one of a small number of books identified by the instructor. Each book is a recent interpretative synthesis of global experience or the experience of some important region. The review will be evaluated on the basis of its success in analyzing and criticizing the book's interpretation or argument. A typical review begins with a broad but brief (200-500 words) overview that situates the book in a broader context and provide a concise summary of the principal contributions or arguments. The major portion of the review, however, is your own critical response to the argument or main points. Do you agree with the author, and why? In giving your views you may find it useful to recapitulate the points with which you are agreeing or disagreeing. Nevertheless, please be careful to avoid a longish descriptive summary. The conclusion of the book review must answer four questions clearly and concisely.

Why was the book written? What is unusual or different about this book? Was the author successful? What do we learn as a result of the efforts of this author?

Please submit two copies of each review along with rough notes, preliminary drafts, marked-up photocopies, etc. One copy of the review will be maintained in a filing system established for that purpose within the Economics Department. Due dates for the review are given above (depending on your option for evaluation). No reviews will be accepted after due date.
