# MATH\*1080, MATH\*1200) Course Description

This course will provide students with a more rigorous analysis of consumer and producer behaviour than is taught in introductory courses. It will focus on the determinants of consumer demand and producer supply in a perfectly competitive context. The problem of monopoly power will be analysed along with that of imperfect competition and game theory.

Investment, Time, & Insurance: Chapter 13 (time permitting)
