



BPS Procurement Directive

Effective April 1st, 2011, the BPS Procurement Directive (Directive) applies to designated broader public sector organizations under the Broader Public Sector Accountability act, 2010. Universities are one of the designated broader public sector organizations that are required to comply with the Directive.
