Course Overview

Calendar Description

Designed specifically for students enrolled in OMAFRA/UofG HQP Scholarship program but open to all students. To provide market-readiness for students as they enter business, government or academia. Teaching modules will cover business developments, intellectual property, patent and license protection as well as societal issues impacting agriculture and food.

Learning Outcomes

This course has three learning outcomes. When you have completed this course, you will:

- (1) Understand and be able to participate in a variety of business and managerial decisions that are made by organizations in the agriculture and food sector
- (2) Understand and communicate effectively about social, ethical and public policy issues facing HQPs in the agriculture and food sector
- (3) Have developed a professional development plan that will position you for a senior leadership position in the agriculture and food sector within 10-15 years of completing your degree

Course Format

Classes comprise short lectures, discussions of cases and other topics, guest speakers, debates, and presentations using a mix of team and individual work. Although most course activities occur during the Monday class time, there are some activities that will require attending University events outside of this class time. Note also that course assignment dates may be changed slightly, and always with a week's notice, to accommodate the availability of speakers

*2 You are expected to attend and learn from all cases, debates, presentations and guest speakers' classes. If you are not presenting a case, speaking in a debate or doing a presentation, you will be assessed on the quality of the questions and comments you provide during these classes. It is expected that students will miss some classes due to professional, graduate academic commitments, illness or other valid reasons. However, if you miss more than 3 classes and you have not communicated the reasons via email, you will not be able to earn full participation points.

Overview of Assignments

Complete assignment details are provided in CourseLink. Brief overviews are provided below.

Cases

Each student will be required to complete a short case report (1500 words, plus exhibits) and presentation for 2 cases. Cases will be provided on CourseLink. Case reports are due 24 hours before class.

Debates

Each student will debate for the affirmative on one topic and for the negative on one topic. You will work with a partner on a topic that will be finalized once course enrolment details are finalized. One debate will be scheduled in the fall semester and the other in the winter semester. You will be asked to submit an outline for your arguments before the debate along with an annotated bibliography. This outline is due 24 hours before class.

Professional Development E-Portfolio and Presentations

Each student will prepare a portfolio comprising evidence and documents such as a value and issues analysis for their research, a linked in profile, a current and future state C.V., interview 3 leaders in their field, prepare and deliver 2 short and one long presentations and complete other activities that will become part of a e-portfolio. All presentation slides are duce 24 hours before class.
