Field Ecology - BIOL*4410

Fall 2014 (Sunday August 17th – Saturday August 30th, 2014)

Course description

This is a 12-day field course held in Algonquin Park, Ontario, during August. Emphasis is on the design and implementation of ecological field experiments; students acquire knowledge of natural history of plants, invertebrates and vertebrates as a result. Students design and conduct a research project in small groups, on any of: vertebrate, invertebrate, or plant ecology, and/or behaviour, in terrestrial or aquatic habitats, and for which an independent formal scientific paper will be submitted. In addition, the students will produce a field notebook highlighting their own natural history interests as well as accurately documenting their observations, data collection, and questions. Both the scientific paper and field notebook are due the last Friday in September. There are no formal lectures, but an organizational meeting is held in the winter semester prior to the field course. Students are responsible for their own transportation to and from the field station.

Learning Objectives

Field Ecology is an opportunity for students to be inspired by, explore, and discover the natural environment. During this course, students will:

- 1. *Generate* hypotheses and predictions, and independently *propose* a study to examine a question of interest in field ecology
- 2. *Apply* the scientific method to *create* and *design* a scientific field study
- 3. *Cooperate* and *collaborate* in small groups of peers to *collect* ecological field data
- 4. Analyze ecological field data and write a scientific paper
- 5. *Observe, document* and *appreciate* the flora and fauna in Algonquin Park
- 6. *Produce* a clearly presented and well-organized field notebook
- 7. *Appreciate* the unpredictable nature of field biology and have the opportunity to *employ* problem solving and improvisation in a remote and rustic environment.
