Course Title: Adv Partial Differencial Equat, Math 4270

Course Description:

The course will discuss the classification of partial differential equations; it will cover theory, applicable methodologies, and examples of the hyperbolic, elliptic, and parabolic types of partial differential equations; it will provide introduction to certain transformation methods and non-linear equations. The course will be based on selected material from Chapter 7-12 of the textbook. Some topics from Chapter 2-6 will be briefly reviewed. Most lectures will follow the textbook. Not all topics will be covered at the same level of depth. The objective of this course is to familiarize the students with the above-mentioned topics and the related techniques.
