# Course Description

This course is an applied community project to examine the tourism and fishing community on Campobello Island, New Brunswick from a sustainable economic viewpoint and provide a report (an environmental scan and economic analysis) that provides a comprehensive evaluation, analysis and recommendations based on available information. Specific topics that will be addressed range from research methodology through selected topics in sustainable tourism, food and hospitality principles; sustainable principles of leadership and multi-sector cooperation; and an integrative view of the local marine environment/economy and community engagement towards sustainability. The course will include an immersive team formation and integration at its outset followed by guided seminars and independent and team study/work aimed at an analysis of the Campobello Island community within the context of sustainable principles. The course will conclude with a report that provides an analysis and a proposal for further field research (to be conducted in the S20 semester).

# Summary of Course Content and Materials

Students will receive an initial grounding in the relevant subjects and strategies, develop a research methodology and plan, and develop an operational/development plan on economic challenges and opportunities that incorporates an environmental scan and economic analysis of the community. Throughout the semester, the students will be supported and guided using resources from faculty and the Campobello community. These interactions will ensure that the initial draft and analysis for Campobello Island reflects the unique opportunities that are present within the community and will support a continued dialogue and support network between the community and the University of Guelph. The team will build on previous work done by the 2018 and 2019 cohorts that went to Campobello Island.
