- **4.0 University of Guelph Committee Representatives.** The list of committee representatives was presented by Sameer Al-Abdul-Wahid, External Committee Liaison, who acknowledged appreciation of their continued efforts and commitment.
- **5.0** Acceptance of 2019 AGM minutes as posted to the PSA website. Motion to accept the 2019 AGM Minutes by Shannon Talbot, Seconded by Cindy Kettle. Carried by poll of member attendees.

Motion by Irene Thompson that the first three recommendations in the Remuneration Report be referred to an *ad hoc* committee formed from an open call for membership volunteers and appointed by the Executive (preferred but not limited to: volunteer committee members that have experience in PSA Executive roles), seconded by Gerrit Bos. Carried by poll of member attendees.

The ad hoc committee shall:

- perform an audit to determine time commitments required for each Executive role and determine the appropriate level of remuneration and differential for each role and/or to further negotiate release time with the University,
- propose a remuneration framework to reflect the increased workload and the increasing complexity of the roles,
- propose a cost of living adjustment framework, cumulative in nature, to be provided every 3-5 years as a means of catching up once each updated honorarium is established, and
- report to the membership at the 2021 Annual General Meeting.

Motion by Irene Thompson that the PSA supplement existing honoraria by \$200 for the Chair, \$150 for the Vice-Chair, \$100 for the Treasurer, and \$100 for the Secretary for the 2020/2021 fiscal year, seconded by Cindy Kettle. Carried by poll of member attendees.
