General Information

Course Title: Cross-Cultural Psychology

Course Description:

Throughout the world, peoples of different cultural backgrounds are increasingly coming into contact through travel, business, work, temporary and permanent settlement, and information and communication technologies. What happens as a result of their contacts can vary from mutual learning and appreciation to hostility and overt conflict. This course provides an examination of cultural differences and of individual and group relations within and between culturally diverse societies from psychological perspectives. The course focuses on two equally important issues. First, we will examine how psychology can help to understand and cope with the diversity of our world. Second, we will examine the validity and generalizability of psychological knowledge in a different cultural context. The aim is to facilitate an understanding of the broad cultural similarities and differences that exist across and within societies.

- 4. Ability to locate, assess, and critically synthesize information on topics in cross-cultural psychology.

Additional Notes:

The final grade is based on a midterm, online quizzes, an essay, a reflection paper, and a final exam. The final exam is **NOT** cumulative. Lectures and reading assignments are examined in each test. All tests consist of multiple-choice items. Both exams will be written in class.

(1) Midterm

Chapters: 1, 2, 3, 4, & 5 and lecture materials.

(2) Final exam

Material includes Chapters 6, 7, 8, 9, and 10, as well as all lecture content covered since the midterm.

(3) Culture Profile Research Paper (25%)

For this assignment, you will work in pairs with a classmate to research a culture that is different from Canadian culture. Using at least **five scholarly sources**, you will explore the group's traditions, norms, and psychological frameworks. You will then apply **one key concept from cross-cultural psychology** to help explain how culture shapes behaviour, social interactions, and worldviews.

Instructions:

1. Choose a Cultural Group for Analysis.

- Select a specific cultural group other than Canadian culture.
- Focus on a well-defined subgroup (e.g., Persians, Chinese, Punjabi, Tamil immigrants, etc.).
- Avoid overly broad categories, such as "Asian culture", "African culture", or "Middle Eastern culture", as these include many diverse and distinct communities. The goal is to encourage focused, in-depth research on the cultural characteristics of a clearly defined group rather than generalizations about large, diverse regions.

2. Define and describe the culture.

- Clearly define the cultural group you are studying.
- Describe at least two key elements of the culture: practices, traditions, norms, and/or values that shape the group's worldview.
- Support your description using peer-reviewed articles, academic books, or other credible scholarly sources.

3. Apply a cross-cultural psychology concept.

- Choose one of the frameworks listed below.
- Briefly define the concept, and then apply it to the culture you selected.
- Use scholarly research to explain how this concept is reflected in the group's beliefs, traditions, and everyday life.

• Support your analysis with **specific examples**, such as behaviours, rituals, social expectations, or communication patterns.

Concept	Sample Focus Areas
Power Distance	Respect for authority, family hierarchy, classroom or workplace roles
Uncertainty Avoidance	Risk-taking, attitudes toward rules or planning
Collectivism vs. Individualism	Family obligations, self-identity, independence vs. group loyalty
High vs. Low-Context Communication	Direct vs. indirect speech, conflict resolution styles
Emotion Expression Norms	Emotional regulation, public expression of sadness/anger/joy
Tightness vs. Looseness	Strength of social norms and consequences of deviance

4. Conclude your paper by explaining the broader significance of understanding these cultural characteristics.

 Discuss how these insights can inform cross-cultural communication strategies, enhance collaboration in multicultural settings, or contribute to the development of culturally sensitive policies and practices.

The essay has to be uploaded on CourseLink by $\underline{November\ 4^{th},\ 11:59\ pm}$ (EST).

The approximate length of the essay is <u>6 to10 pages</u> (not including title page and reference section). Papers submitted after the deadline will receive a penalty of **5% per day late** (including weekends). No paper is accepted after the last class, November 27th.

The pedagogical reasoning:

This assignment is designed to deepen your understanding of how behaviours, attitudes, and social norms vary across cultural contexts. By researching and analyzing a cultural group different from Canadian culture, you will critically examine your own cultural assumptions and explore how psychological and societal frameworks influence human thought and behaviour. Applying key

concepts from cross-cultural psychology will enhance your ability to recognize cultural differences and understand their broader implications, equipping you to engage more thoughtfully and respectfully with individuals from diverse backgrounds.

(4) **Online quizzes (10%)**

Twelve quizzes are administered online via CourseLink. Your final quiz grade is based on your best 10 scores out of the 12 quizzes. Each quiz is worth 1% of your final grade and includes five questions.

Ten quizzes correspond to the ten textbook chapters, and two quizzes focus on the midterm and final exam materials. Each quiz becomes available on the day we finish the corresponding chapter and remains accessible on CourseLink for 24 hours. For example, if we finish Chapter One on September 11th, the quiz will be available until 11:59 PM on September 12th. Please note that no make-up quizzes will be offered if you miss one.

The pedagogical purpose of these quizzes is to familiarize students with the format and content of questions that will appear on the midterm and final exams, as well as to help students assess their understanding of the course material in an ongoing, low-stakes format.

Grading and Deadlines

- Quiz grades will be updated on CourseLink weekly.
- It is your responsibility to regularly check your grades and inform the instructor as soon as possible if a mark is missing.
- You have until the last day of class to report missing quiz grades. After this deadline, no further changes will be made, and a score of zero will be recorded for any unreported quizzes.

(5) Reflection Paper (10%)

Cultural Detective: Observing the Everyday

In this reflection assignment, you will take on the role of a "cultural detective" to observe everyday human behaviour and interactions. The goal is to notice how people act, communicate, or interact in ways shaped by culture, and to reflect on your own assumptions and reactions. Unlike the major paper, this assignment is personal, experiential, and does not require research or citations. Through this exercise, you will gain insight into how culture shapes human behaviour and how your own cultural background influences the way you interpret the world around you.

Instructions:

1. Choose a Context:

- Select a public space (e.g., park, classroom, shopping area) or an online community (e.g., social media group, forum).
- Look for behaviours, interactions, or social practices that are different from what you
 typically expect or are familiar with.

2. Observe a Behaviour or Interaction:

o Pick one specific behaviour, interaction, or custom that caught your attention.

o <u>Examples:</u>

Greeting or farewell rituals

• Use of personal space

• Communication style (direct vs. indirect, formal vs. casual)

Emotional expression (laughing, apologizing, showing frustration)

Describe this particular phenomenon without judging it as "weird" or "wrong."

3. Reflect on Your Observations:

o Describe your initial reaction: Were you surprised, confused, amused, or curious?

o Consider your own assumptions: How might your cultural background have influenced

how you interpreted what you observed?

Reflect on what this observation taught you about cultural differences and human

behaviour.

o Focus on your personal insight—there is no need to reference course materials or academic

sources.

4. Write Your Reflection:

o Length: 500–600 words, double-spaced, in Times New Roman, 12-point font.

o Include:

Context and description of the behaviour

Your personal reactions and assumptions

• Insights gained about culture and human behaviour
