Course Title: PSYC*7994 Cognitive Behaviour Therapy Practicum

Course Description: This course is intended to foster clinical psychology graduate student training in cognitive behaviour therapy (CBT) and will include didactic and experiential components. Students will gain competency with the theory and practice of CBT for child and adolescent mental health challenges, gain facility with treatment manuals and undertake at least two ongoing therapy cases with a CBT approach.

Course Content

Specific Learning Outcomes:

Upon successful completion of the course, students will be able to:

- 1. Explain cognitive and behavioural conceptual models pertinent to children and adolescents and the research that supports them.
- 2. Explain commonly used techniques and procedures of CBT.
- 3. Develop case formulations concerning child and adolescent clients using a cognitive- behavioural framework.
- 4. Demonstrate proficiency in the implementation of behavioral techniques such as behavioral activation, activity scheduling, graded task assignment, graded exposure, and relaxation training.

- 5. Demonstrate proficiency in the implementation of cognitive techniques such as thought records and other means to challenge distorted thinking.
- 6. Demonstrate novice competency in the treatment of child and adolescent clients using cognitive-behavioural therapy by working with 1 client at the Maplewoods Centre. This includes: collaborative empiricism, psychoeducation, session structuring, challenging negative thinking, self-instruction, Socratic method, homework assignment and therapeutic alliance in video-recorded sessions.
- 7. Demonstrate competency in assessing and monitoring treatment process and progress.
- 8. Demonstrate skill in effective written and verbal communication.
- 9. Identify key ethical considerations in implementing cognitive-behavioural therapy and psychotherapy more generally with children and adolescents.
- 10. Demonstrate professional and ethical behavior when working with children, adolescents, and families in a therapeutic context.
- 11. Engage in ways to prepare for and benefit most from clinical supervision (both individual and group supervision).
- 12. Self-reflect on own professional development (e.g., clinical goal setting and monitoring, exploration of strengths and areas for further development, self-awareness).

Lecture Content:

The above learning outcomes will be met through structured didactics as well as direct work with a therapy client. Specifically, students will meet weekly for didactic components covering a range of CBT and behavioral parent training techniques. Once oriented to CBT, students will be assigned a therapy case at the Maplewoods Centre. During the Winter semester, it is expected that students will have approximately 1 hour a week of therapy delivery associated with the course. Students will meet with their instructor and/or teaching assistant on a weekly basis for group and individual supervision to discuss video-taped therapy sessions, session notes, and to plan for ongoing therapy.

Additional Notes:

- 1. Clinical Competence in CBT: Students will gain competence in CBT through didactics as well as the direct clinical application of learned skills. Students will build their skillset primarily in the Fall semester and apply their skills in their clinical work with 1 therapy case (primarily in the Winter semester). All client sessions will be video-taped and evaluated for clinical competency and treatment adherence by the instructor or teaching assistant. Feedback will be provided on a regular basis during individual and group supervision. More formalized evaluations will occur at end of term.
- 2. Participation and engagement in experiential activities: Students are expected to come to class prepared by completing assigned readings for the discussion of CBT theory and practice (when applicable). Students are also expected to come prepared to engage in experiential activities. These activities may include discussion, modelling of skills, and role-plays. These are meant to prepare students for therapy sessions with actual clients by offering an opportunity to familiarize oneself with the specific therapeutic approaches.
- 3. <u>Client Documentation:</u> Students are expected to hone their skills writing concise, accurate and useful session notes to document their clinical work. Documentation may also include assessment, conceptualization, and treatment planning reports (when applicable).
- 4. <u>Tape Viewing Log and Supervision Notes:</u> Students are expected to come prepared to supervision to discuss their own growth and development as therapists with additional notes outlining their personal process with delivering CBT, reactions to clients, inferences about clients that do not belong in session notes and general success and challenges as novice therapists. To accomplish this, students will regularly watch their session recordings and identify discussion points (e.g., areas of strength/challenge, questions, reactions).

5. <u>Case Presentations:</u> During the Winter semester, students will provide a case presentation about their client from a thoughtful and unique lens (i.e., not just a start-to-finish recounting of the course of treatment). Presentations are expected to be around 30 minutes.
